Event title

Inclusive VNRs 2024: How can the VNR process enable diverse civil society perspectives on progress of the SDGs?

Background and Rationale

This year, six UNECE countries showcase their Voluntary National Reviews (VNRs), prompting a crucial reflection midway through the 2030 agenda. Stakeholders play a pivotal role in evaluating achievements, offering insights, and shaping the narrative ahead.

This session provides a platform for discourse between Member States and Civil Society stakeholders, exploring progress, inclusivity in engagement, the right to participation and future SDG prospects within the national context of VNR countries.

Participants will reflect on how to strengthen broad participation in the VNR process and how this in turn influences a collective assessment of SDG progress, enabling a common understanding of gaps and defining necessary actions to fulfil the promise of the 2030 Agenda.

Session objectives and expected outcomes

The session will provide key insights into ways to enhance stakeholder participation in the VNR process across the ECE region and will aim to provide joint learning to enable stronger engagement of civil society groups in coming years. The session will also include discussion of useful accountability tools, such as the People's Scorecards, which allow for an independent comparative view on progress.

The learning from this session will aim to provide input for a further event on inclusive VNRs at the High Level Political Forum in New York in July.
