Advancing key transitions and cooperation towards achieving the Sustainable Development Goals in the UNECE region

Sustainable development brings the promise of a better future, but to build this future, we need to imagine it, to remove obstacles that undermine the necessary cooperation to make it possible, and to harness all the levers that contribute to progress. And we need to ensure that all the actors are involved in a meaningful way. The future does not only belong to us. The commitment to safeguard the interest of future generations is a key component of sustainable development.

The plenary session will open with reporting back from the five peer learning round tables, followed by a segment on the Summit of the Future. The Co-Facilitators of the Summit will offer insights on the state of play of Summit preparations, listen to interventions and react to questions from the floor.

A panel discussion will subsequently bring together diverse stakeholders, including financial institutions, science and academia, youth and civil society. Panellists will share with member States their perspectives on SDG acceleration with particular focus on the main issues to be addressed by the Summit of the Future. A debate with interventions from the floor concludes the plenary session.
